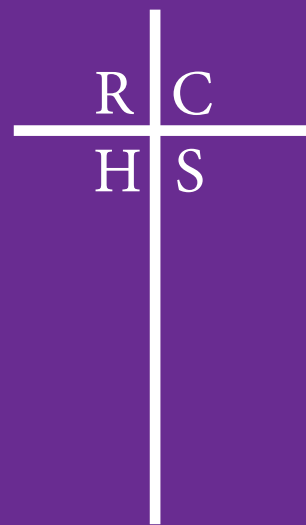

From the Board President

Dear Families and Friends of Rouff,
The 2013-14 school year brought about many changes to Rouff. We were awarded grant money from the Tracy Family Foundation and Cargill. The Tracy Foundation awarded us with a \$30,000 grant to initiate bus transportation for a morning route from the Virginia and Franklin areas. Twenty-two students from both OSS and Rouff are utilizing this service. A \$2500 grant received from Cargill, was written by parent, Sandy Beddingfield, and helped us purchase an additional SmartBoard. Dan Nash, IT Director, has been able to replace many of the older models with newer ones with a return program from the SmartBoard company.

The ACT scores continue to be above the state average. This year's juniors had a composite score of 23.7, with the state average at 21.0. The class of 2014 had 90% of the class attending a post-secondary school (in a 2-or 4-year program).

A security system is now in place at the school. In March, the security doors were installed and by the end of the school year several cameras were replaced and a few more added. A video of each camera can be viewed by the Principal and the Main Office Secretary. Visitors must press a buzzard to be permitted in the building after the school day begins.

The 2013-14 student population began with 117 students, for various reasons, the school year ended with 108 students. Out-of-parish students make up 6% of the student body and students of other faiths total 29%. Five percent of Rouff students are eligible for a free or reduced lunch, while 44% receive some form of tuition assistance. We are blessed to offer over \$70,000 in tuition assistance with the family endowments and named scholarships.

With the persistence of Jim Burke, and the monetary donations of generous donors, a program created by the Bigger, Faster, Stronger, Inc., is in place at Rouff. We have always done a great job with the spiritual and academic side of education, but lacked in the physical portion. The expanded fitness center now has room to hold a full class of students with state-of-the-art equipment. Heath Wilson, AD, and trainers have been certified to provide guidance in using the equipment for all of our students, not just the athletes.

Beginning July, 2014, Mr. Nick Roscetti was hired to begin as the new RCHS Principal and Superintendent. We look forward to the 2014-15 school year.

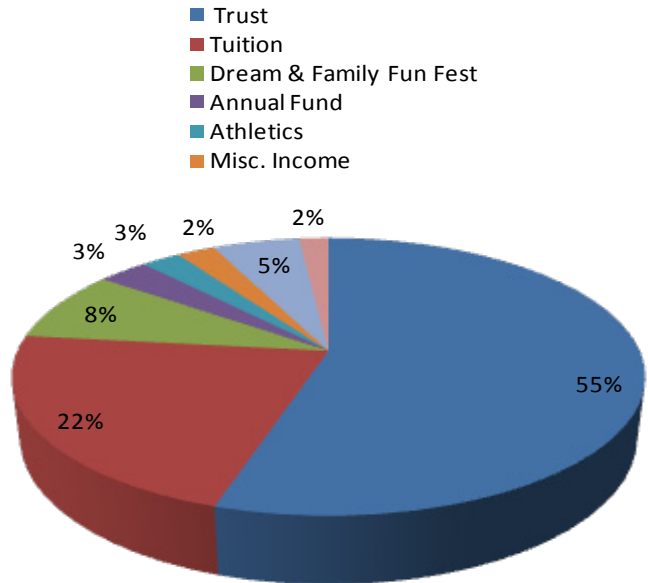

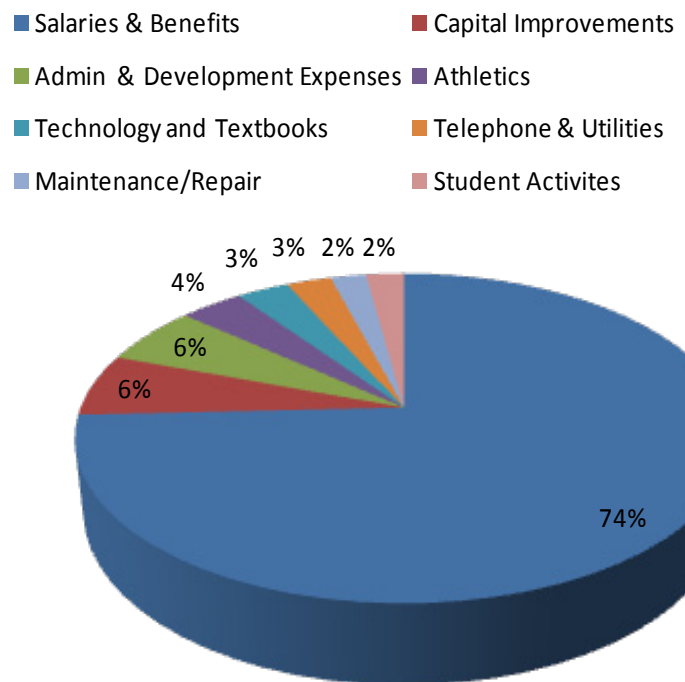

Enrollment and Tuition

Routt Catholic High School enrollment for 2013-14 school year ended with 108 students in grades 9 - 12. Routt admits students of any race, nationality and religion without discrimination with respect to ability or achievement levels, believing that all have a right to a Christian education. Out-of-parish students make up 6% of the student body and students of other faiths total 29%. Also, 5% of Routt students are eligible for a free or reduced lunch.

The Board again voted not to increase tuition for the fifth year in a row, keeping tuition at \$3,700 with \$200 fees for all families. Families can also receive a waiver of half of the fees as an incentive for early enrollment. The Routt Board is committed to holding tuition at a level our families can manage, especially in difficult economic times.

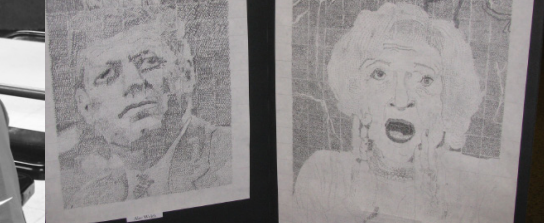
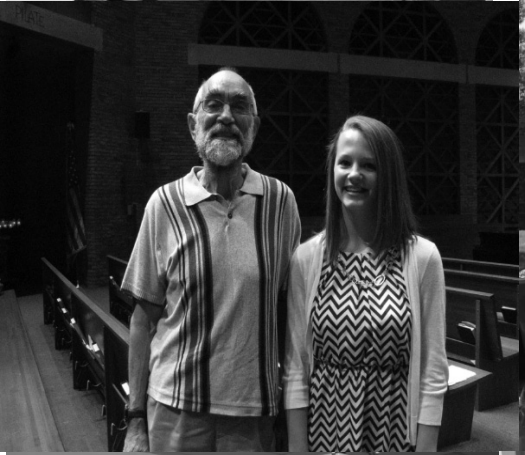

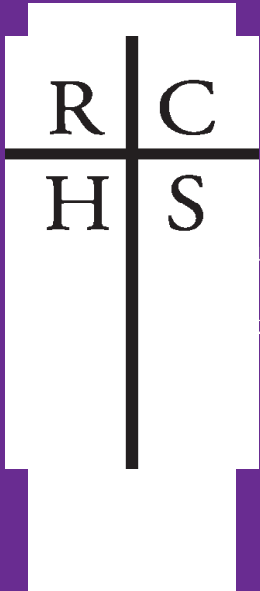
